Permission, Waiver, Release and Indemnity Agreement

In consideration of the student named below (the "Student") being permitted to participate in programs and activities at Greenbrier Christian Academy, the undersigned parent(s) or legal guardian(s) of the Student, hereby agree to the following terms and conditions set forth below:

1. Participation: Permission is granted for the Student to participate in programs and activities during the 2026-2027 school year with the understanding that the Student is not mandated to participate. I/We understand and acknowledge that certain risks are inherent and I/we assume liability and responsibility for any such risks associated with participation in the program and/or activity.
2. Expectations: I/We understand and acknowledge that the Student is expected to abide by all school regulations during the course of the program/activity. I/We agree to direct the Student to cooperate with the directions and instructions of the supervisory personnel in charge.
3. Hold Harmless: I/We acknowledge that, as a condition of the Student's participation in this program/activity, I/we hold harmless and waive any and all claims against Greenbrier Christian Academy, its officers, employees, agents, and volunteers, including, but not limited to, claims arising out of the ordinary negligence of any officer, employee, agent, student or volunteer of the School, or any loss or damage to personal property occurring during or by reason of the Student participating in this program/activity.
4. Release from Third-Party Liability: I/We understand that Greenbrier Christian Academy is not an agent of, and has no responsibility for, any third party, including without limitation, any sponsor or program that may provide any services, equipment, training or activities associated with the program/activity.
5. Indemnification: as a condition of the Student's participation in the program/activity, I/We indemnify Greenbrier Christian Academy for all claims resulting from the Student's participation including but not limited to any injury, accident, illness, or death, or any loss or damage to personal property.
6. Medical Care: I/We consent to any of the staff, employees, agents and representatives of Greenbrier Christian Academy administering or consenting to the administration of such emergency medical care to the Student as such person deems appropriate in the circumstances and hereby authorize medical treatment in case of emergency.

7. Medical Insurance: I/We understand and acknowledge that Greenbrier Christian Academy does not carry or maintain health, medical, or disability insurance coverage for the Student and therefore agrees to assume the responsibility for such insurance coverage on the Student.
8. Medical Conditions: I/We agree that we have provided Greenbrier Christian Academy, during the reenrollment or admissions process for the 2026-2027 school year, current information concerning any medical or physical conditions, including, but not limited to, allergies, asthma, and medications, of the Student, and names and phone numbers for emergency contacts if not already on file with Greenbrier Christian Academy, or if such information has changed since that which was filed with Greenbrier Christian Academy. Please check RenWeb to verify the accuracy of information that is on file with Greenbrier Christian Academy. If any changes are made to the medical information in RenWeb, as a result of this permission and waiver form, notify Greenbrier Christian Academy immediately.
9. Severability: If any provision of this agreement is held invalid or unenforceable, the remainder of this agreement shall remain in full force and effect. If any provision is held invalid or unenforceable with respect to particular circumstances, it shall remain in full force and effect in all other circumstances.
10. Voluntary Agreement: The student and the parent(s)/guardian(s) acknowledge that they have read the "Permission, Waiver, Release and Indemnity Agreement" and are aware of the legal consequences of signing this binding document. My signature below indicates that I have read and freely signed this agreement. I further certify that I am legally competent to sign this agreement.
